## **2010 TELEPHONE DIRECTORY COVER CONTEST**

Pioneer Communications is conducting a contest to choose the **2010** telephone directory cover. The contest is open to anyone who receives telephone service from Pioneer. It is also open to persons whose parent or guardian receives telephone service from Pioneer.

Each entrant may submit up to three entries. The entry can be a photograph, painting in any media, graphic, sculpture, needlepoint or collage. **ENTRIES MUST BE SUBMITTED AS AN 8 X 10 PHOTO, WHICH WOULD REPRESENT HOW IT WOULD LOOK ON THE COVER ITSELF.** The actual painting or artwork can also be submitted along with the 8 X 10 photograph.

The subject may be of the artist's choosing, however it must depict some aspect of Pioneer Communications' service area which consists of all or portions of Finney, Grant, Hamilton, Haskell, Kearny, Morton, Seward, Stanton and Stevens Counties in Kansas and Baca and Prowers Counties in Colorado.

While entrants will retain ownership of the winning artwork, entry into the contest grants Pioneer the right to display the artwork for a period of ninety days after the deadline date for submission. Pioneer Communications will have the right to reproduce the artwork for use as the **2010** telephone directory cover or for any other purpose.

Entries, which must be accompanied by a completed entry form, are to be submitted to any of Pioneer Communications' business offices. Pioneer has business offices located in Hugoton, Lakin, Syracuse, Satanta, Johnson and Ulysses. If one person submits more than one entry, each entry must be accompanied by its own entry form.
